

RESOLUTION NO. 2014-

Mayor Engelstad offered the following resolution and moved its adoption:

WHEREAS, the following property had received final Certificates of Occupancy for two units as a result of a subdivision approval of the Mother Lot block 26, lot 8; and

WHEREAS, these two property units were not billed for prior year sewer utility charges, and

WHEREAS, it has been the Borough's policy in the past to backbill for usage as it is the property owner's responsibility to report correct information to the Sewer Utility Collector's office; and
