**RESOLUTION 2023-17**

**RE-APPOINTING ERICK AGUIAR AS BRADLEY BEACH  
MUNICIPAL TAX ASSESSOR**

**WHEREAS**, pursuant to N.J.S.A. 40A:9-146 et seq. and Borough of Bradley Beach Ordinance 5-27, there exists a need for the Borough of Bradley Beach to appoint a qualified individual to serve as Tax Assessor; and

**WHEREAS**, Erick Aguiar has served as Bradley Beach Assessing Clerk from January 8, 2019 to February 1, 2019, appointed Tax Assessor for an unexpired term from February 2, 2019 to June 30, 2019 and appointed to a first four-year term from July 1, 2019 to June 30, 2023; and

**WHEREAS**, Erick Aguiar possesses a Tax Assessor Certificate, as provided for and required by N.J.S.A. 54:1-35.25 et seq. and N.J.S.A. 40A:9-148.1; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-148, the Tax Assessor shall hold a term of office for four years, from the first day of July next following his appointment; and

**WHEREAS**, notwithstanding the foregoing N.J.S.A. 54:1-35.31 provides that a Tax Assessor that has been reappointed and has served not less than four consecutive years prior to such reappointment shall be entitled to tenure; and

**WHEREAS**, the Borough seeks to re-appoint Erick Aguiar to the position of Tax Assessor of the Borough of Bradley Beach.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, hereby re-appoints Erick Aguiar to the position of Tax Assessor of the Borough of Bradley Beach effective July 1, 2023, and in accordance with the Statutory Tenure that Mr. Aguiar has attained by virtue of his re-appointment, as set forth herein.
