**RESOLUTION 2023-81**

**AUTHORIZATION TO AWARD THE OCEAN PARK AVENUE  
STORMWATER OUTFALL EMERGENCY REPAIRS  
IN THE AMOUNT OF \$1,318,300.00**

Mayor Fox offered the following resolution and moved its adoption:

**WHEREAS**, Kimberly M. Humphrey, QPA, Borough Administrator and Colliers Engineering & Design, Borough Coastal Engineer, have determined that there is a need for the acquisition of the following goods and services:

**Ocean Park Avenue Stormwater Outfall Emergency Repairs**

**WHEREAS**, the project will consist of repairs to the Ocean Park Avenue Stormwater Outfall Pipe.

**WHEREAS**, Colliers Engineering & Design received Emergency Bids via email on Monday, February 13, 2023; and

**WHEREAS**, three (3) bids were received as follows:

**WHEREAS**, Kimberly M. Humphrey, QPA, Borough Administrator and Colliers Engineering & Design, Borough Coastal Engineer, have reviewed the bids and recommend that the award of contract be made to **George Harms Construction** in the amount of **\$1,318,300.00** as the lowest responsible bidder; and

**WHEREAS**, the Borough Attorney, Greg Cannon has reviewed the bid proposal package of the lowest bidder, and declares them to be in conformance with the Borough's Instructions to Bidders and the Local Public Contracts Law and recommends an award of contract to **George Harms Construction** as the lowest responsible bidder; and

**WHEREAS**, funds are available to make such purchase or acquisition and have been certified as such by Anthony Mannino, CFO, and said certification being attached to the resolution.

**NOW THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey as follows:

1. An award of contract for the Ocean Park Avenue Stormwater Outfall Pipe repair, as outlined hereinabove, is hereby made to **George Harms Construction, 62 Yellowbrook Road, Howell, N.J. 07731** in the amount of **\$1,318,300.00** as the lowest responsible bidder.
2. The Mayor and Municipal Clerk are hereby authorized to execute the Borough standard form of Contract for Goods and Services reference herein and made a part of this award of contract as well as any non-substantive modifications thereto and related constituent documents.
3. The Municipal Clerk is directed to forward a certified copy of this Resolution to the Qualified Purchasing Agent, Chief Financial Officer, Borough Engineer, Borough Attorney and George Harms Construction.
