**RESOLUTION 2023-94**

**AUTHORIZATION TO AWARD THE LAKE TERRACE PARK  
ADA IMPROVEMENTS TO TC LANDSCAPE CONSTRUCTION  
IN THE AMOUNT OF \$159,486.00**

Mayor Fox offered the following resolution and moved its adoption:

**WHEREAS**, the Mayor and Council of the Borough of Bradley Beach have determined that there is a need for the acquisition of the following goods and services:

**LAKE TERRACE PARK ADA IMPROVEMENTS**

**WHEREAS**, the project will consist of ADA Improvements to Lake Terrace Park.

**WHEREAS**, the Borough of Bradley Beach has received a matching Monmouth County Open Space Grant in the amount of \$70,000.00; and

**WHEREAS**, a notice of advertisement for a re-bid and an invitation to the re-bid were prepared and advertised in accordance with the Local Public Contracts Law; and

**WHEREAS**, sealed bids were opened and read on Tuesday, February 28, 2023 at 10:00 a.m. in accordance with the requirements of the Local Public Contracts Law; and

**WHEREAS**, four (4) bids were received as follows:

**WHEREAS**, Kimberly M. Humphrey, QPA, Borough Administrator and Bennett Matlack, P.E, CME, CFM Borough Engineer, have reviewed the bids and recommend that the award of contract be made to **TC Landscape Construction** as the lowest responsible bidder; and

**WHEREAS**, Greg Cannon, the Borough Attorney has reviewed the bid proposal package of the lowest bidder, and declares them to be in conformance with the Borough's Instructions to Bidders and the Local Public Contracts Law and recommends an award of contract to **TC Landscape Construction** as the lowest responsible bidder; and

**WHEREAS**, funds are available to make such purchase or acquisition and have been certified as such by Anthony Mannino, Chief Financial Officer.

**NOW THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey as follows:

1. An award of contract for the **Lake Terrace Park ADA Improvements**, as outlined hereinabove, is hereby made to **TC Landscape Construction, 1456 Grand Central Parkway, Bayville, N.J. 08721** in the amount of \$159,486.00 as the lowest responsible bidder.
2. The Mayor and Municipal Clerk are hereby authorized to execute the Borough standard form of Contract for Goods and Services reference herein and made a part of this award of contract as well as any non-substantive modifications thereto and related constituent documents.
3. The Municipal Clerk is directed to forward a certified copy of this Resolution to the Qualified Purchasing Agent, Chief Financial Officer, Borough Engineer, Borough Attorney and TC Landscape Construction.
