**RESOLUTION AUTHORIZING THE DISCUSSION OF MATTERS

- **Affordable Housing Litigation**

**BE IT FURTHER RESOLVED**, that the following persons are expected to attend this Executive Session: 1) Mayor & Council, 2) Borough Administrator, 3) Borough Attorney, 4) Municipal Clerk.

**BE IT FURTHER RESOLVED**, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.

**BE IT FURTHER RESOLVED**, minutes will be kept of said executive session, which minutes shall be confidential and shall not be disclosed to the public until the need for confidentiality no longer exists.
