AUTHORIZATION TO AWARD THE PARK PLACE AVENUE – PHASE I IMPROVEMENT PROJECT TO FERNANDES CONSTRUCTION IN THE AMOUNT OF \$559,187.30

WHEREAS, sealed bids were opened and read on Friday, September 15, 2023 at 11:00 a.m. in accordance with the requirements of the Local Public Contracts Law; and

WHEREAS, six (6) bids were received as follows:
