**RESOLUTION 2023-248**

**AUTHORIZING AWARD OF PROPOSAL FOR PROFESSIONAL ENGINEERING SERVICES WITH CME ASSOCIATES FOR THE STORMWATER INFRASTRUCTURE MAP UPGRADES TO CONFORM WITH THE NJDEP REQUIRMENTS**

Mayor Fox offered the following resolution and moved its adoption:

**WHEREAS**, the Borough of Bradley Beach has a need to acquire professional services relative to engineering services required for the Stormwater Infrastructure Map Upgrades to conform with the NJDEP Requirements; and

**WHEREAS**, CME Associates submitted a proposal dated August 17, 2023, to provide engineering services relative to the Stormwater Infrastructure Map Upgrades to conform with the NJDEP Requirements; and

**WHEREAS**, said proposal consisted of the following services and costs:

**Stormwater Infrastructure Map Upgrades to conform with NJDEP requirements.**

**Amount: \$25,000.00**

**WHEREAS**, the Borough Mayor and Council finds it to be in the best interest of the Borough of Bradley Beach to authorize said work; and

**WHEREAS**, funding will be available through a Stormwater Assistance Grant that the Borough applied for and was awarded a Grant in the amount of \$25,000.00.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that the Mayor and Municipal Clerk are authorized to enter into a Contract with CME Associates as described therein.

**BE IT FURTHER RESOLVED** that the Clerk is hereby authorized and directed to cause a notice to be published in the manner provided by law setting forth the nature, duration, service, and amount of the Contract and that the resolution and Contract are on file in the Office of the Clerk and are available for public inspection.
