

**BOROUGH OF BRADLEY BEACH**

**RESOLUTION 2024-1**

**ADOPTING THE TEMPORARY OPERATING BUDGET FOR THE YEAR 2024.**

**WHEREAS, N.J.S.A. 40A:4-19** provides that where any contract, commitment or payments are to be made prior to the final adoption of the annual municipal budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

**WHEREAS,** as required by said statute, this resolution is adopted during the first thirty (30) days of the 2024 fiscal year; and

**WHEREAS,** the total appropriations in the 2023 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund, and public assistance were as follows:

<b>CURRENT FUND.....</b>	<b>\$10,480,879.15</b>
<b>DEDICATED SEWER UTILITY.....</b>	<b>\$1,789,700.00</b>
<b>DEDICATED BEACH UTILITY.....</b>	<b>\$2,322.600.00</b>

**WHEREAS,** the temporary operating budget for 2024 shall not exceed 26.25% of the total appropriations in the 2023 budget exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund, and public assistance. Therefore the temporary budget appropriations for 2024 I shall not exceed the following:

<b>CURRENT FUND.....</b>	<b>\$2,751,230.78</b>
<b>DEDICATED SEWER UTILITY</b>	<b>\$469,796.25</b>
<b>DEDICATED BEACH UTILITY</b>	<b>\$609,682.50</b>

**WHEREAS,** the Chief Financial Officer has prepared the following Temporary Operating Budget and recommends its adoption (SCHEDULE A attached).

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Bradley Beach in the County of Monmouth, State of New Jersey, that the attached Temporary Operating Budgets for the Current Fund, Sewer Utility, and Beach Utility are hereby adopted.

**BE IT FURTHER RESOLVED THAT** a certified copy of said Resolution be forwarded to the Chief Financial Officer.
