**AUTHORIZING AWARD OF PROPOSAL FOR PROFESSIONAL ENGINEERING SERVICES WITH CME ASSOCIATES FOR PROMENADE EXTENSION – PHASE I.**

**WHEREAS**, the Borough of Bradley beach has a need to acquire professional services relative to engineering services required for the Promenade Extension – Phase I Project; and

**WHEREAS**, CME Associates submitted a proposal dated May 2, 2024, Revised October 17, 2024, to provide engineering services relative to the Promenade Extension – Phase I Project; and

**WHEREAS**, said proposal consisted of the following services and costs:
