## **RESOLUTION 2024-42**

## **RESOLUTION AUTHORIZING EMERGENCY CONTRACTS PAUL DAVIS RESTORATION OF MORRIS AND PASSAIC COUNTIES**

**WHEREAS**, the Local Public Contracts Law permits the award of emergency contracts pursuant to <u>N.J.S.A.</u> 40A:11-6 et. seq., subject to certain criteria, and

**WHEREAS,** the Local Public Contracts Law pursuant to <u>N.J.S.A.</u> 40A:11-6 et seq. allows the award of contracts without public advertising for bids and bidding when an emergency exists affecting the public health, safety or welfare which requires the immediate delivery of goods or the performance of services, wherein the award of contract is made in the manner prescribed by the aforesaid statutory provision; and

**WHEREAS,** the Borough of Bradley Beach has determined that an emergency exists, wherein due to an unsatisfactory microbial clearance after recent roof replacement, August 2023, there was a compromise in the moisture and microbial integrity of the Biase Center; and

**WHEREAS,** as a result of the aforesaid emergency, there was/is a need to conduct mold remediation and associated demolition in order for employees, community members and volunteers, including Meals for Wheels, to work and meet inside the Biase Center; and

**WHEREAS**, the Acting Borough Administrator and Purchasing Agent has determined that the aforesaid emergency affects the public health, safety and/or welfare; and

**WHEREAS,** in accordance with the aforesaid declaration and pursuant to <u>N.J.S.A.</u> 40A:11-6 et. seq., the aforesaid emergency project is awarded to:

• Paul Davis Restoration of Morris and Passaic Counties in an amount not to exceed \$55,000;

**WHEREAS**, certification of funds having been made by the Chief Financial Officer, that funds are available for the said purpose.

**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Borough of Bradley Beach that the contracts for the aforesaid emergency mold remediation and demolition and are hereby authorized and ratified with <u>vendor(s)</u>.

**BE IT FURTHER RESOLVED,** that these contracts are being awarded without public advertisement for bids pursuant to an emergency situation affecting the public health, safety and/or welfare, and as authorized by the Local Public Contract Laws, in accordance with <u>N.J.S.A.</u> 40A:11-6, which permits the awarding of emergency contracts.

**BE IT FURTHER RESOLVED,** that the Borough officials, including but not limited to, the Borough Administrator, are hereby authorized to execute the said emergency contracts, as well as any and all documents required to effectuate the same.
