**RESOLUTION AWARDING BID FOR  
317-319 LAREINE AVENUE DEMOLITION**

**Mayor Fox** offered the following Resolution and moved its adoption:

**WHEREAS**, the Borough of Bradley Beach has a need to retain the services of a qualified contractor to perform certain demolition services at its public property known as and located at 317-319 LaReine Avenue, Bradley Beach, NJ 07720; and

**WHEREAS**, the Borough solicited bid via duly advertised specifications, which were due on or before December 20, 2024; and

**WHEREAS**, the Borough received bids from eight (8) contractors to perform the demolition services as follows:

**WHEREAS**, under the Local Public Contracts Law, Greg Lertch Demolition Excavating, LLC has been determined to be the lowest responsible bidder;

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that a contract is hereby awarded to Greg Lertch Demolition Excavating, LLC in the amount of \$348,500.00 for certain demolition services at its public property known as and located at 317-319 LaReine Avenue, Bradley Beach, NJ 07720; and

**BE IT FURTHER RESOLVED**, that the Mayor and the Municipal Clerk are authorized to execute and attest to an agreement with Greg Lertch Demolition Excavating, LLC pursuant to the bid specifications, and in a form approved by the Borough Attorney; and

**BE IT FURTHER RESOLVED**, that the Municipal Clerk shall publish a notice of this action in the official newspaper of the Borough within ten (10) days from the adoption of this Resolution; and

**BE IT FURTHER RESOLVED**, that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference; and

**BE IT FURTHER RESOLVED** that the bid and bid securities of the second and third lowest bidders shall be retained and held open, pending execution of the awarded contract by Greg Lertch Demolition Excavating, LLC; and

**BE IT FURTHER RESOLVED** that the Municipal Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, Borough Engineer, Greg Lertch Demolition Excavating, LLC, and to the unsuccessful bidders.
