24-002 – 606 5th Ave – Remove 3 trees (Priv) - All 3 on private property. Trees just removed PRIOR to STC approval. L. Bagwell noted some "center rot" on tree located on the far east side of property. A. Gubitosi asked if homeowner will replace? Not noted by homeowner in application. L. Bagwell will notify the homeowner of the amounts owed. Bagwell motion; Kosarych Second to approve with conditions to replace or pay for replacements.
 24-003 – 212 Brinley Ave – Remove 1 tree (Planting Strip) with 2 replacements. Bagwell motion; Kosarych Second to approve with conditions to replace or pay for replacements.
24-004 – 409 Newark Ave – Remove 1 tree (Planting Strip) 2 replacements. Asked to remove because building will be demolished. Trip hazard. 91 year old tree. Replacement tree is native to North Carolina and mountain locations, requires shade. C. Davidson questioned its salt tolerance? L. Bagwell wil show "Approved Tree" list to use for replacements. Maybe suggest "Red Bud" alternative? Kosarych motion, C. Davidson

second to approve with conditions to use native tree alternatives. Unanimous approval. 24-005 – 415 Park Place Ave – Remove 3 trees (Priv) 5 replacements. Twelve months allowed to replace - per L. Bagwell not "hard and fast" rule. C. Davidson suggests that Japanese Tree Lilac will behave Invasively; may need alternative. Applicant is present and states they can be flexible on replacements. Hollies are good replacement choice. Gubitosi motion, Bagwell second to approve with conditions that will do additional research on replacements that might be more applicable. Unanimous approval.
Wishing Tree Applications – To Date: 1. Would have liked more at this point. Would like more applications. L. Bagwell suggests that he will knock on doors in his neighborhood AND will speak with DPW to see if there are public spaces that could use trees. N. Weinberg mentioned that there are two large areas on Second Ave down by beach that could use trees. L. Bagwell will follow-up to see if it is possible to plant trees in these spaces (Second Ave median) for Spring Planting. N. Kosarych asks if J. DeNoble can put in plug for Wishing Trees in the next "Tree of the Month" posting.
