## **Mayor Fox:**

Mayor Fox reiterated the Governing Body's process to welcome disagreements but try to understand different perspectives. Mayor Fox encouraged everyone to have a constructive voice this evening, gauge their tone as we are all neighbors and continue join in the vision to improve Bradley Beach.

### **Mayor Fox:**

Captain Arnold received a Bachelor of Science with high honors degree from Rutgers University. He began his career in 2000 as a Special Law Enforcement Officer and a Dispatcher before being sworn in as a Patrolman in 2002. In 2006 Mr. Arnold joined the elite Monmouth County Emergency Response Team (MOCERT) where he rose to the position of 'Team Leader' before retiring from the team in 2020.

Mr. Arnold was assigned to the Detective Bureau from 2012 until 2016, there he was promoted to Sergeant. As a Sergeant, Mr. Arnold became the lead instructor for the Southern Monmouth County Active Shooter Partnership, a training program inclusive of twelve shore towns.

In 2019, Captain Arnold was promoted to Lieutenant and in 2023, he was promoted to Captain. During his career, Mr. Arnold also served as the Police Department's Traffic Officer and Firearm's Instructor.

Since mid-November of 2023, Mr. Arnold has been the "Officer-in-Charge" of the BBPD. He has done an admirable job; and I believe has the support of the Police Department. He certainly has mine.

Councilman Weber, Councilman Gubitosi, Councilwoman DeNoble, and Councilwoman Mahoney all expressed their gratitude and praise to Captain Arnold for taking on this role and look forward to collaborating with him as their Chief of Police.
