**AWARD OF CONTRACT FOR PROFESSIONAL ENVIRONMENTAL ENGINEERING SERVICES  
WITH CME ASSOCIATES FOR A PRELIMINARY ASSESSMENT AND SITE INSPECTION (PASI)  
FOR THE BRADLEY BEACH RECREATION CENTER**

**WHEREAS**, the Borough was awarded a Local Recreation Improvement Grant in the amount of \$74,000.00 and a matching Monmouth County Municipal Park Improvements Grant in the amount of \$265,000.00 as the result of the applications submitted by CME Associates on behalf of the Borough; and

**WHEREAS**, CME Associates submitted a proposal dated December 13, 2023 and revised downward on February 8, 2024 to a total cost of \$7,000.00; and

**WHEREAS**, a Preliminary Assessment and Site Inspection (PASI) is a requirement of the Monmouth County Municipal Park Improvement Grant; and

**WHEREAS**, the Governing Body finds it to be in the best interest of the Borough of Bradley Beach to authorize said work; and

**WHEREAS**, funding is available for this purpose as attested by the Chief Financial Officer from the following account 4-01-20-165-000-206.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that the Mayor and Municipal Clerk are hereby authorized to enter into a contract with CME Associates as described herein.



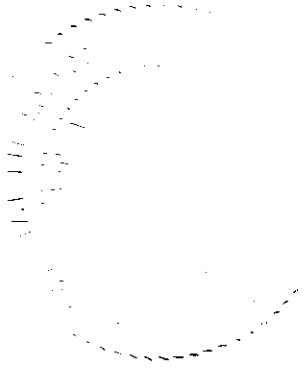
