# AUTHORIZING A PRIVATE SALE OF SURPLUS PROPERTY BY THE BRADLEY BEACH DIVISION OF FIRE

WHEREAS, the Bradley Beach Division of Fire (the "Division"), within the Department of Public Safety, provides protection of life, property, and the environment from the effects of fires and hazards within the Borough of Bradley Beach (the "Borough"); and

WHEREAS, the Division is in possession of certain surplus property (Schedule A attached) which is owned by the Borough and is no longer needed for public use; and

WHEREAS, the Division advises that said surplus property is old and inoperable, and its scrap value is less than 15% of the bid threshold; and

WHEREAS, pursuant to N.J.S.A. 40A:11-36, surplus property valued at less than 15% of the bid threshold may be sold at private sale without advertising for bids, upon the approval, by Resolution, of the Borough's Governing Body; and

**WHEREAS**, the Commission therefore recommends that the Borough sell said surplus property at private sale, without advertising for bids, to recover its scrap value;

**NOW, THEREFORE, BE IT RESOLVED,** by the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that the above forementioned list of surplus property shall be sold at private sale without advertising for bids.
