- Personnel Policy Review
- Garrison vs. Bradley Beach

BE IT FURTHER RESOLVED, that the Mayor & Council shall reconvene in public session upon conclusion of the executive session discussions, which shall be approximately Thirty (30) minutes following the adoption of this Resolution; and

BE IT FURTHER RESOLVED, that the following persons are expected to attend this Executive Session: 1) Mayor & Council 2) Borough Attorney, and 3) Municipal Clerk.

BE IT FURTHER RESOLVED, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.
