**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough of Bradley Beach as follows:

- 1. <u>Cannon & McGuinn, LLC</u>, is hereby appointed as **OPRA Counsel** for the calendar year 2025 and is awarded a Professional Service Contract for professional legal services provided for the period of January 1, 2025 through December 31, 2025.
- 2. The contract is awarded without competitive bidding since the appointments involve members of recognized professions that are registered by law, therefore exempt under **N.J.S.A. 40A:11-5**.

- 5. A copy of this resolution shall be published in the newspaper as required by law within ten (10) days of its passage.
