## PROFESSIONAL CONTRACT APPOINTMENT FOR AN ALTERNATE LABOR ATTORNEY

WHEREAS, the Borough has reviewed all proposals received and has determined that the Mayor and Council desires to authorize the execution of a professional services contract between the listed person(s)/firm(s) and the Borough for the year of 2025.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough of Bradley Beach as follows:

- 1. <u>Plosia Cohen Law Firm</u>, is hereby appointed <u>Alternate Labor Attorney</u> for the calendar year 2025 and is awarded a Professional Service Contract for professional legal services provided for the period of January 1, 2025 through December 31, 2025.
- 2. The contract is awarded without competitive bidding since the appointments involve members of recognized professions that are registered by law, therefore exempt under **N.J.S.A.** 40A:11-5.
- 3. The services rendered shall be in compliance with the Laws of New Jersey.
- 4. A copy of this resolution and the contract shall be placed on file with the Municipal Clerk.
- 5. A copy of this resolution shall be published in the newspaper as required by law within ten (10) days of its passage.
- 6. This award is being made subject to the above-named professional/firm's execution of the Professional Services Contract Addendum setting forth the assignment and reporting Requirements of all professionals working for the Borough.
