- 1. <u>Shain Schaffer, PC</u>, is hereby appointed <u>Tax Appeal Attorney</u> for the calendar year 2025 and is awarded a Professional Service Contract for professional legal services provided for the period of January 1, 2025 through December 31, 2025.
- 2. The contract is awarded without competitive bidding since the appointments involve members of recognized professions that are registered by law, therefore exempt under **N.J.S.A. 40A:11-5**.
- 3. The services rendered shall be in compliance with the Laws of New Jersey.

- 5. A copy of this resolution shall be published in the newspaper as required by law within ten (10) days of its passage.
