POLICE:

Police made an arrest in regard to multiple thefts occurring in the Borough and neighboring towns. The investigation is still ongoing, and the Detective Bureau is working closely with the other jurisdictions.

FIRST AID:

For the operational period ending November 9, 2021, the Squad responded to 26 Day calls and 11 Night calls for a total of 37 calls; 24 calls were for medical and 8 were for fire. There were three requests for Mutual Aid to assist Neptune City, Neptune City and Avon First Aid, there were no COVID-19 cases. The squad participated in the annual Halloween Parade providing medical coverage. The Squad fulfilled 100 % of their assignments for this operational period.

FIRE DEPARTMENT:

For the operational period ending, November 9,2021 the department had 8 requests for the Department. The Department participated in the annual Halloween Parade. The Department conducted the OHSA mandatory mask fit test for all interior Firefighters the Department is now in full compliance with that requirement. The Department fulfilled 100 % of their assignments for this operational period.

The Fire Department and First Aid Squad are accepting for volunteers. Both offer free training for qualified individuals. Anyone wishing to volunteer for the Fire Department or First Aid Squad, applications can be found on the Borough's website.

The cooperation that exists between the Fire and First Aid Squad is allowing them to keep answering the citizen's needs for medical care and fire protection.

Councilman Sexsmith reminded everyone of the Veteran's Day Ceremony to be held at Riley Park this Thursday 11/11/21 at 11:00 a.m.

Councilman Weber encouraged everyone to view the 10/12 Council Meeting to which Councilman Gubitosi made a personal plea for people to discuss issues facing the town and not

turn them into personal attacks.
