Administrator Brown gave the following report:

UTILITY COORDINATION MEETINGS

The Administration is setting up meetings with all the various utilities and adjacent public agencies (i.e. JCP&L, NJAW, NJNG and NJ Transit) to meet with their various Government Affairs officials to forge a better relationship with them, to request proper coordination and to attempt to get the Borough Utility bills under one account. So far, we have met with NJAW and it went very successful.

NJ DIRECT INSTALL REBATE PROGRAM

The Borough next week will be hosting Hutchinson and its partners that will perform a lighting survey and subsequently installation for the NJ Rebate Program for the Borough approved locations. The Administration expects this to save thousands of dollars to the Borough to install energy efficient lighting and controlled motion sensitive lighting that should reduce our electric bills.

ENERGY AGGREGATION

I recently was in touch with the Borough Administrator of the Borough of Red Bank and he reported that they were completing the draft RFP for our solicitation of an energy aggregation consultant. The draft RFP will be circulated to all the participating towns next week and then the group can finalize the RFP. The Borough of Red Bank will issue the RFP, receive the proposals and then the participating towns can evaluate the respondents and then the Borough of Red Bank can officially designate the consultant on behalf of the group. So, all this means is that we are getting closer to the Energy Aggregation program kicking off.

IT PAY\$ TO PLUG IN

The Borough is assessing the It Pay\$ to Plug In program, which provides grants to offset the cost of purchasing and installing electric vehicle charging stations. The program is designed to expand New Jersey's growing network of electric vehicle infrastructure, allowing residents, businesses, and government agencies to purchase and drive electric vehicles. EVs dramatically reduce vehicle emissions and improve air quality for everyone. More to come on this in the future.

2019 AUDIT

Chief Financial Officer Sandra Rice announced the 2019 Audit was delivered to the Borough on Friday, February 19, 2021 and has been sent to the Governing Body electronically via email. Ms. Rice stated an exit interview with the previous Auditor was conducted Friday, February 13th. Ms. Rice stated the Audit report will be made available to the public after Governing Body approval and signature of the affidavit.

Ms. Rice reported she and the Borough Administrator are researching to possibly consolidate telephone, internet and cable services to save money to the Borough.
