# REGULAR MEETING MINUTES March 23, 2021 at 7:45 pm

A regular meeting of the Mayor and Council of the Borough of Bradley Beach was held by means of communication equipment, N.J.S.A. 10:4-8(b), to include streaming services and other online meeting platforms and formal action will be taken on the above date.

#### **CALL TO ORDER**

Mayor Fox opened the meeting with a salute to the flag.

Sunshine Law

The meeting has been noticed publicly according to the Open Public Meetings Act requirement for the "Annual Notice", and posted on the official bulletin board.

Mayor Fox mentioned summer resident Chris Daley's U-Conn team is doing well.

Mayor Fox announced the Zoom Chat Room will not be used this evening due to inappropriate comments and baseless accusations towards Professionals in the Municipality at the March 9<sup>th</sup> meeting. Mayor Fox continued while commentary is welcomed and encouraged, it needs to be kept constructive moving forward in future meetings.

#### Workshop Discussion(s):

#### Marijuana Prohibition Under New Law

Borough Attorney Greg Cannon stated Zoning Ordinance 2020-5 prohibiting cannabis use in the Borough has been declared null and void by the Cannabis Act. Mr. Cannon explained under the Cannabis Act, it indicates any Municipality within 6 months after adoption can adopt an ordinance prohibiting cannabis businesses with the exception of delivery services within the Municipality's borders. Mr. Cannon stated this ordinance would need to be adopted by August 22, 2021 if the Borough wishes to continue their prohibition. Mr. Cannon explained the prohibition is valid for five years and would need to be renewed upon expiration. Mr. Cannon stated if the Municipality does not adopt a prohibition ordinance, the current Cannabis Act would be in effect & the Borough would have to wait until August of 2026 to adopt a prohibition ordinance. Mr. Canon advised adopting a prohibition ordinance this year and stated if the Borough decides to go in a different direction in the future, the ordinance can be reversed.

Mr. Cannon stated the Cannabis Act is comprehensive with respect to Police powers in the Municipality and explained the Police Officers enforce cannabis consumption the same as alcohol consumption.

Mr. Cannon recommended updating all of the park and public consumption regulations along with underage consumption regulations to include prohibition of cannabis.

**Council Comment on this Workshop item:** 

Councilman Sexsmith thanked Mr. Cannon for his review of the Cannabis Act and is confident the Borough will reenact the Ordinance adopted last year.

Councilman Gubitosi thanked Mr. Cannon for his thorough summary and mentioned Ordinance 2020-5 addressed restricting cannabis facilities and asked if an amendment would be made to the current Zoning Ordinance to restrict the five Zoning classes.

Mr. Cannon recommended re-adopting the Zoning Ordinance in addition to adopting a Prohibition Ordinance.

Councilman Bonnell suggested focusing on the retail end and feels that is where cannabis can become problematic.

Mr. Cannon agreed and recommended amending all of Ordinance 2020-5.

Councilman Weber thanked Mr. Cannon for his presentation and inquired if the new ordinance will have to go before the Planning Board for a consistency hearing.

Mr. Cannon responded yes.

Public Comment on this Workshop item:

Thomas J. Coan, 612 Third Avenue, asked Mr. Cannon if the Borough will be able to meet the time requirements.

Mr. Cannon responded the Opt-Out is the most important plan to introduce at the next meeting if possible.

Paul Neshamkin, 411 ½ LaReine Avenue, inquired if there was a suggestion to do a referendum on the original Ordinance.

Councilman Weber responded no and stated a workshop was done originally in 2018.

Mr. Neshamkin stated is surprised the Borough is anti-cannabis.

Mayor Fox stated he was not sure of the percentage of Bradley Beach votes for the overall referendum question on the 2020 Election Ballot.

Mr. Weber stated in the original workshop discussion, no one was against medical marijuana however being a neighboring town that is in favor of these facilities for medical

and recreational use, the thought process is that people can go to the next town if they choose to purchase it.

William Psiuk, 110 Fifth Avenue, thanked the Governing Body for re-addressing this and moving this back to the Planning Board for consistency review with the Master Plan.

Mayor Fox thanked Mr. Cannon for his diligence on this and thanked the Council and the public for their constructive input.

Third Party App Based Food Delivery Charge

Mayor Fox hopes to get more data and information on this topic in the next few weeks and gave an overview of what the third party app is and how it affects restaurants financially. Mayor Fox is in the process of getting feedback from restaurant owners in town regarding putting an ordinance in place and stated it would be better for Bradley Beach to do this with other towns for leverage purposes. Mayor Fox stated he will be contacting Hoboken and Jersey City to see if this is beneficial to their towns so far and has reached out to surrounding towns to see if they would be in favor of this ordinance and stated there will be a Round Table discussion with Borough restaurant owners on 3/30/21 to seek feedback from them.

# **Administrative Report:**

#### FORMER CHURCH PROJECT

On March 4, 2021, the Administration contracted T&M Associates for \$6,840 to provide the Borough with a Structural Evaluation. This assessment is in progress and a report is expected in April 2021.

The Administration recently received the final draft of the General Specification for the Lead-Based Paint Abatement Project and for the Asbestos Abatement Project at the Former Church from Environmental Testing Consultants. Environmental Testing Consultants prepared the Bid Specifications for \$3,800. The Notice to Bidders is now public on the Borough Website and advertised via the Borough's Official Newspapers. An on-site pre-bid conference and walkthrough of the site will be held on March 25, 2021. Bids will be received on Thursday, April 8, 2021 and opened publicly in Borough Hall and on Zoom.

#### BOARDWALK HORSESHOE PROJECT

The Borough is out to bid for the second time to receive proposals on the Specifications to Furnish and Deliver Boardwalk Materials. Bids are due Wednesday, March 31, 2021. The Borough is expected to receive at least one bid this go around, however if we do not the Borough in accordance with the Local Public Contracts Law is allowed to negotiate with a local vendor for the materials.

# NEWARK AVENUE, CLIFF AND KENT AVENUTES PAVING PLAN PHASE I

Today the Borough held a preconstruction meeting with APCO Construction and deployment of the heavy equipment and personnel is anticipated to start mid-April 2021.

# Mayor Fox reported the following:

- There will be an Arbor Day Celebration on April 30<sup>th</sup> at 5:30 p.m. at the Second Avenue Park.
- A Green Fair will take place in Riley Park on April 24th.
- Announced as per the State, Lifeguards are considered First Responders and are eligible to get the COVID-19 vaccine.

# **Public Comment:**

MaryAnn Spilman, 902 Ocean Avenue, inquired on the status on the Beachfront

Playground and asked about several pieces of equipment.

Councilman Bonnell and Mayor Fox answered Ms. Spilman's inquiries.

Julie Nutaitis, 605 Newark Avenue, commended the town's generosity toward those affected by the fire and stated she would like to see the town move ahead with the United Methodist Church project.

Allen Rapaport, 512 Newark Avenue, congratulated Administrator Brown for his one year Anniversary, commended the CFO for her work with the Budget and commended the town for their generosity with residents affected by the fire.

Mr. Rapaport expressed concerns with the Community Center project being deterred by the Movie Theater and inquired if the Governing Body has had further discussion with the Theater Group.

Mayor Fox responded there has been no discussion with the Theater Group and the Community Center project and the Movie Theater are completely decoupled.

Paul Neshamkin, 411 ½ LaReine Avenue, congratulated Administrator Brown on his one year anniversary.

Mr. Neshamkin concurred with Ms. Nutaitis and Mr. Rapaport with regards to the Community Center project and expressed concern with the lack of Community Center Task Force discussions. Mr. Neshamkin continued he is in support of both the Community Center and the Movie Theater. Mr. Neshamkin stated he has discussed funding with the Theater Group and has not received a follow up from them. Mr. Neshamkin stated if he does not receive a follow up from them he will invest the funds he planned on using for the Movie Theater into the Community Center instead.

Thomas J. Coan, 612 Third Avenue, congratulated the Shade Tree Commission on their status as Tree City USA.

Mr. Coan inquired if the revenue for the sewer pump sold recently sold by the Borough can be used for the purchase of a new sewer pump and avoid taking the money from the 2021 budget.

Administrator Brown explained that is not possible; once an item is sold the revenue cannot be placed in the current year budget, however it can be used the following year.

Mr. Coan expressed concern the Zoning and Planning Board videos are not being posted to the website.

Mayor Fox stated he will look into this.

Jack Gentempo, 103 Fourth Avenue, stated he is in favor of moving forward with the Community Center Project.

# Ordinance Adding "Chapter 198: Third Party App-Based Food Delivery Regulations" to the Municipal Code

# Body

WHEREAS, restaurants in the City of Hoboken have suffered tremendously on account of COVID-19; and,

WHEREAS, third-party app-based food delivery services, charge between 15 and 30 percent of a bill to a local restaurant; and,

WHEREAS, local hospitality businesses are already facing unprecedented financial challenges as a result of the State of Emergency; and,

WHEREAS, all stakeholders must step up to protect the integrity of Hoboken's hospitality industry during this and any State of Emergency; and,

NOW THEREFORE BE IT RESOLVED by the Council of the City of Hoboken that we hereby standby our hospitality businesses and add a new section to our municipal code, helping them during this and any future State of Emergency capping delivery fees from third party-apps.

#### 198-1 DEFINITIONS

RESTAURANT: A business in which food and/or beverage preparation and service is provided for individual consumption either on- or off-premise, and in which any service of alcoholic beverages is accessory to the service of food

THIRD-PARTY, APP-BASED FOOD DELIVERY PLATFORM: Any website, mobile application, or other internet service that offers or arranges for the sale of food and beverages prepared by, and the same-day delivery or same-day pick-up of food and beverages from a food service establishment

ONLINE ORDER: An order placed through a platform provided by a third-party app-based food delivery platform for delivery within Hoboken

PURCHASE PRICE: The menu price of an online order. Such term excludes taxes, gratuities, and any other fees that may make up the total cost to the customer of an online order.

### 198-2 RESTRICTIONS

- A. It shall be unlawful for a third-party, app-based food delivery platform to charge a restaurant a commission fee for online, delivery or pick-up order for the use of its services that totals more than 15% of the purchase price for listing, processing and delivery services, or 8% for listing and processing services of such online order while the City of Hoboken is under a state of emergency.
- B. It shall be unlawful for a third-party, app-based food delivery platform to reduce the compensation rates paid to the delivery service driver, or garnish gratuities, as a result of this order going into effect during the duration of this order.
- C. This ordinance shall be in effect during all State of Emergencies.

## 198-3 PENALTIES

A. Any person found to have knowingly violated this ordinance, and upon conviction may be punished by a fine of not more than \$500 or by imprisonment for not more than 180 days or both such fine and imprisonment.
