ORDINANCE 2021-18

AN ORDINANCE AMENDING SCHEDULE III: "PARKING TIME LIMITED ON CERTAIN STREETS" AND SCHEDULE VI: "THROUGH STREETS" ATTENDANT TO CHAPTER 9: "TRAFFIC" OF THE BOROUGH'S REVISED GENERAL ORDINANCES TO IMPLEMENT NEW REGULATIONS ON 2ND AVENUE AND 3RD AVENUE BETWEEN MAIN STREET AND HAMMOND AVENUE WITHIN THE BOROUGH

Mayor Fox offered the following Ordinance and moved its introduction:

WHEREAS, the Borough of Bradley Beach, County of Monmouth, and State of New Jersey (the "Borough") seeks to improve parking capacity, public safety, traffic flow, and resident quality of life through the construction of certain improvements and the implementation of certain new regulations on 2nd Avenue and 3rd Avenue between Main Street and Hammond Avenue; and

WHEREAS, in order to implement the traffic and parking regulations attendant to the overall improvement plan for 2nd Avenue and 3rd Avenue between Main Street and Hammond Avenue, certain amendments to the Borough's traffic and parking regulations are necessary;

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, and State of New Jersey as follows:

SECTION 1. "Schedule III" entitled "Parking Time Limited On Certain Streets" of Chapter 9: "Traffic" of the Revised General Ordinances of the Borough of Bradley Beach is hereby supplemented with the following:

Name of Street	Side	Time Limit	Hours	Location
Third Avenue	Northerly	15 Minutes	All Times	Two (2) westernmost parking spaces
Second Avenue/ Third Avenue	Southerly	Loading Zone Only	4:00 a.m. to 2:00 p.m.	Three (3) westernmost parking spaces

SECTION 2. "Schedule VI" entitled "Through Streets" of Chapter 9: "Traffic" of the Revised General Ordinances of the Borough of Bradley Beach is hereby amended as follows (~~stricken~~ text deleted; underlined text added):

Second Avenue


- a. Between Ocean Avenue and Third Avenue
- b. The intersection of Third Avenue and Second Avenue is hereby designated as a yield stop intersection. ~~A yield~~ Merging traffic warnings and stop sign(s) shall be installed on the ~~easterly approach of~~ Second Avenue facing westbound traffic.


SECTION 3. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION 4. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other parts, portions and provisions of The Revised General Ordinances of the Borough of Bradley Beach are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 5. This Ordinance shall take effect upon adoption and publication in accordance with the laws of the State of New Jersey.
